



This Membership Agreement is made and entered into this _____ day of _____, 20___ by and between Liberty Shooting Range LLC DBA Target Shooting Solutions (hereinafter referred to as “TSS”) and _____ (hereinafter referred to as “Member”). This Membership Agreement will govern the terms and conditions of the Member’s privileges and obligations and constitutes a binding contract between the Member and TSS. By signing this Membership Agreement, you indicate that you have read and agree to all terms and conditions of the Membership Agreement and that you are agreeing to be legally bound by all terms and conditions set forth in this Membership Agreement for a period of 365 days beginning upon signing of this Membership Agreement and payment of Membership Dues.

1. Assumption of Risk and Hold Harmless: I have read the Assumption of Risk, Indemnity and Liability Waiver Agreement, Range Rules and understand and agree to their terms and conditions.
2. Membership Dues: Membership dues are payable in full at the time of purchase. Family Membership additions can be made either at the time of purchase or at any point during the duration of membership and shall be active concurrently for the duration of the original Membership.
3. Membership Responsibilities: Members are fully responsible for the actions of themselves, their guests and family members. Members are fully responsible for their personal property and that of their guests and/or family members. In no case will TSS be held responsible for theft, loss or damage to any Member, guest or family property.
4. Eye and Ear Protection: Eye and ear protection is required at all times by Members and guests while in the range.
5. Right of Revocation: Members, guests or family members who fail to obey any and all Range Rules, range officer instructions, basic firearms safety rules, TSS policies and/or any other terms of membership are subject to expulsion of the range, suspension or revocation of their membership or range usage rights in general. There will be no refund of any monies, membership dues or other fees if any person is required to leave TSS property or any membership is suspended or revoked as noted herein. TSS reserves the right to terminate any Membership Agreement at any time.
6. Range Closure: TSS may from time to time conduct training classes, private events or range maintenance. Accordingly, TSS reserves the right to close part or all of the range to Members and the general public as deemed necessary. TSS will make all reasonable efforts to minimize range closings and to notify Members prior to closing the range.
7. Prohibited Members and Rules: Any persons forbidden by law from possession of firearms are not permitted to utilize TSS facilities and will be removed from the premises. By signing this Membership Agreement, you are expressly representing that you are not prohibited by law or any court order from possessing firearms, you are not under a domestic violence restraining order or injunction and that you are mentally fit to engage in the use of firearms. Members shall not be permitted to enter the premises if they are or appear to be under the influence of alcohol or drugs. Members understand and agree that the consumption of alcohol or drugs is expressly prohibited at TSS, and that any person(s) who appear to be under the influence of



alcohol or drugs, or who appear to be emotionally unstable, shall be denied access to any and all of TSS property.

8. **Damage to Range Property:** Any damage caused to TSS property, whether deliberate or unintentional, is the sole responsibility of the Member. Members will be responsible for the repair or replacement of any damaged equipment. Members shall not intentionally shoot at walls, floors, ceilings, carriers or anything other than approved targets. Members are fully responsible for the actions of their guests and/or family members. Member hereby consents to TSS charging credit cards, bank cards or bank accounts for the cost of any damages.
9. **No loaded firearms** are to be left unattended for any reason. All firearms must be unloaded and contained in a case, holster or tote prior to arrival at the range lane. All firearms must be unloaded and placed back in a case, holster or tote prior to exiting the shooting lane. Please note that this does not mean we're asking you to unload your holstered personal defense firearm.
10. **Cameras:** TSS features many state-of-the-art security cameras, both inside and outside the building. Entry and/or use of TSS facilities indicates that you acknowledge and agree to be monitored and/or recorded on camera. Photographs, images or videos may be used for promotional purposes by TSS. Member hereby releases his or her likeness to be used by TSS without further consent.
11. **Membership Possession:** Single or Individual Membership applies solely to Member and cannot be transferred or gifted to a third party. All member benefits are applicable only to Member and do not extend to guests or any third party. Family Membership applies to only Members listed within primary membership and cannot be transferred or gifted to a third party.
12. **Family Membership:** Family Membership additions apply only to adults 18 years of age or older who share a primary residence with original Member. Family Member additions to membership are limited to four individuals (original Member plus up to three additional Members).
13. **Vouchers and Coupons:** Any and all vouchers, coupons or other materials provided to Member are solely the responsibility of the Member. Guest pass vouchers and coupons must be presented and redeemed at the time of service. TSS is not responsible for lost, stolen or damaged vouchers, coupons and/or membership materials.
